JOB PURPOSE

Many young people, particularly those from socio-economically deprived areas, face an endless maze of boredom, loneliness and temptation, with nowhere to go and a lack of inspiring and productive activities to occupy their leisure time.

This can lead to negative impacts on their health, educational attainment and career prospects. These are the young people that will shape the country's future prospects. It is this paradox that lies at the heart of QCCA's and GOALYC's drive to establish youth service provision that is aligned to community needs and supported by cross-sector funding.

QCCA give 8-19 year olds, those with a disability, affordable access to a broad range of sport, arts and employability services, designed to help them lead active, positive lives and raise their aspirations for themselves and their community.

Open five days a week, and during school holidays, the QCCA and GOALYC purpose is to help young people grow to be happy, healthy and successful adults.

Our facility will provide young people with access to a range of activities, all offering young people the opportunity to try new things, meet new friends and gain support from friendly, warm and positive staff and volunteers.

The facilities include a state of the art indoor sports hall , a gym, recreation area, and, music and media suites.



We are looking to recruit an experienced individual to join the team, with solid, hands on experience in delivering high quality, open access youth work, and managing targeted projects, to lead the team of full and part time staff and volunteers to provide an incredible service to the young people of Camden.

The successful candidate will oversee operational management, monitoring, safeguarding and front-line delivery of this multifaceted service which includes universal, targeted and sports activities.

KEY DUTIES AND RESPONSIBILITIES

- Line manage the youth work team, ensuring the environment is safe and welcoming and all necessary administrative duties are performed
- Leading in the management of outreach activities
- Welcoming young people into the buildings, ensuring everything is running smoothly and supporting young people engaging with the services
- Delivering drop in sessions i.e. organising games and positive activities
- Facilitating the delivery of creative and partnership projects
- Having conversations with young people, identifying issues affecting them and how their needs can be met. Identifying and referring when targeted youth support is needed.
- Mentoring, coaching and supporting individuals, encouraging young people to develop their selfawareness, independence and individuality
- Ensuring that all projects are properly documented, are delivered within budget and that work is evaluated and data input into management systems
- Leading on the development and delivery of cross-hub projects. Examples might include working with young people who identify as LGBTQ and inter-generational programmes.
- Staying informed on legislation, local and national issues, and best practice in youth work
- Being the Designated Safeguarding Person and ensuring child protection procedures are followed and that the safeguarding of young people is paramount
- To lead on the planning and design of QCCA and GOAL's youth work and ensure the delivery of quality and effective programmes with tangible outcomes.
- To develop a regular programme of open and targeted youth projects, activities and events in the wards of Gospel Oak and Haverstock with a particular emphasis on informal personal, social and vocational learning.
- To review how the youth service monitors its work. This takes in everything from capturing the
 journeys of the young people who come to us, down to record-keeping of session attendances and
 accredited outcomes.



- To manage a youth volunteer placement programme, working in partnership with schools, other youth clubs and other establishments.
- To promote educational attainment, access to apprenticeships and employment opportunities for young people aged 16-21 years using a range of formal and informal methods of engagement including one-to-one surgeries.
- To work with trainers and facilitators to deliver accredited qualifications.
- To organise and deliver needs-based group work with young people utilising a wide range of resources and facilities including music, drama and sport.
- To maintain an accurate inventory of resources and facilities.
- To work with QCCA programme co-ordinators to cross-refer young people and their families to our other services (including the food bank, family health activities etc).
- To work directly with young people delivering activities as well as providing support and access to specialist services, where required.
